LEADERSHIP FUND:

The leadership fund is meant to provide current undergraduate/graduate students with funding to attend conferences that will provide opportunities to advance their educational and career aspirations. In order for individuals to qualify for these funds, the Beta Chi Theta Foundation must endorse the initiative as a meaningful educational or professional development event. Grants will also be provided for pre-approved events/conferences hosted by IFC, MGC, NAPA, and more that relate to Fraternity/Greek development. Grants will be awarded on a rolling basis. Thus, students are encouraged to apply early for consideration of funding.

Eligibility:

The eligible student must meet the following requirements:

- Full-time student pursuing an undergraduate or a graduate degree.
- Cumulative grade-point average no lower than 3.0.
- Must be an active member of the Beta Chi Theta National Fraternity.*
- Leadership roles within the fraternity at a national or chapter level.
- Must have good financial standing with the Beta Chi Theta Chapter.*

***Applies to current undergraduate students only**

Application Process:

The Beta Chi Theta Foundation will accept applications on a rolling basis. Individuals are encouraged to apply for such funding in advance. We recommend individuals apply at least 90 days prior to the actual event date.

All requirements and documentation are to be uploaded prior to submitting your application. However, by making an account on Form Site, you can save your progress as well and submit your application once you have met all requirements.

Selection Process:

The Executive Board of the Beta Chi Theta Foundation will consider each application on a rolling basis and will (together) make the final decision in choosing which applications will receive funding.

Funding:

Maximum funding per event/per student will be \$500. Funding will help cover the costs related to the event registration fee, flights, accommodation, and related expenses. If accepted for funding, the Foundation will directly pay for costs discussed previously. Funds will NOT be directly given to the applicant.

TRAVEL & TRIP RISK ACKNOWLEDGEMENT/LIABILITY WAIVER FORM

II. LIABILITY WAIVER / RISK ACKNOWLEDGEMENT:

I _____, understand that participation in trip activities could involve risk of physical injury, illness, death or property loss, and despite safety precautions, the Beta Chi Theta Foundation or Beta Chi Theta Fraternity cannot guarantee safety thereof, as all risks cannot be prevented. The Beta Chi Theta Foundation does not provide health and accident insurance for trip participants, and I understand that any medical expenses, property loss, or other personal expenditures that result during or from this travel/trip, are to be borne by the student/participant, or by their parent or guardian. I also hereby consent, give authorization to, and release from liability; trip leaders to secure any emergency medical treatment in event I am unable to, and I agree to be responsible for the costs thereof.

I further acknowledge that if I drive my own vehicle, or am a passenger in another's private vehicle in connection with this trip/function, that the Beta Chi Theta Foundation's or Beta Chi Theta Fraternity's insurance does not cover such a private vehicle. I also understand that the Fraternity or Fraternity's Foundation cannot be responsible for assuring the safety and reliability of such private transportation or driver, nor for any non-sponsored activities and travel that I/my child might choose to participate in before, during or after the sponsored function, and I therefore accept the risks and responsibilities associated with such private vehicle travel and activities.
